This is a summary of the annual report for the AMERICAN POSTAL WORKERS ACCIDENT BENEFIT ASSOCIATION, (Employer Identification No. 02-0181885, Plan No. 501) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). ### INSURANCE INFORMATION

The plan has a contract with Sun Life Assurance Company of Canada to pay the following types of claims incurred under the terms of the plan. All Accidental Death and Dismemberment claims. The total premiums paid for the plan year beginning January 1, 2023 and ending December 31, 2023 were \$87,489.

#### BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$1,313,729 as of December 31, 2023 compared to \$1,011,375 as of January 1, 2023. During the plan year the plan experienced an increase in its net assets of \$302,354. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$1,827,899. This income included employee contributions of \$1,746,411, realized gains of \$8,969 from the sale of assets and earnings from investments of \$66,609. Plan expenses were \$1,525,545. These expenses included \$1,068,843 in administrative expenses and \$456,702 in benefits paid to participants and beneficiaries.
